


Relative Spectral Emission 5), 6)


Radiation Characteristics 5), 6)






Forward current 5), 6)

 $I_F = f(V_F)$; single pulse; $t_p = 100 \mu s$




Radiant Intensity 5), 6)




Max. Permissible Forward Current




Permissible Pulse Handling Capability




